Abstract

This standard provides consensus quantitative definitions of explosion characteristics for a single point explosion in air, along with methodologies for scaling these characteristics for a wide range of yield and ambient air conditions. ABSTRACT

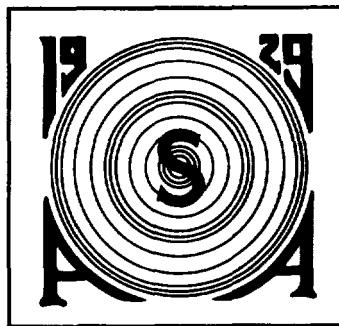
