REVISED AMERICAN NATIONAL STANDARD/AMERICAN DENTAL ASSOCIATION STANDARD NO. 1000 FOR A STANDARD CLINICAL DATA ARCHITECTURE

The Council on Dental Practice of the American Dental Association has approved American Dental Association Standard No. 1000 for a Standard Clinical Data Architecture. Working Groups of the ADA Standards Committee on Dental Informatics (SCDI) formulate this and other standards and technical reports for the application of information technology and other electronic technologies to dentistry's clinical and administrative operations. The ADA SCDI has representation from appropriate interests in the United States in the standardization of information technology and other electronic technologies used in dental practice. The standard was forwarded to the American National Standards Institute with a recommendation that the standard be approved as an American National Standard. Approval of ADA Standard No. 1000 as an American National Standard was granted by the American National Standards Institute on February 22, 2010.
