1 Scope

This British Standard specifies the requirements and test methods of fireguards intended for use with heating appliances utilizing organic fuel (e.g. gas, solid fuel, oil) or electricity, and which can be situated in an open area or against or on a wall, or within a recess.

Such appliances can be permanently fixed in position or can be moveable, and can incorporate open fires including combination grates, or closed fires, including room heaters and stoves.

The fireguards specified in this standard are intended to protect people from falling into a fire, prevent burns and reduce the risk of injury, particularly to young children and the infirm. In addition it is intended to reduce the risk of fire resulting from clothing and/or other flammable materials coming into contact with, or in proximity to, burning fuel and/or hot surfaces.

The fireguards specified are not intended to reduce the risk of fires caused by flying particles, which are covered by [BS 3248](#).

NOTE Examples of different types of fireguards are illustrated in [Annex A](#).

3 Terms and definitions

For the purposes of this British Standard, the following terms and definitions apply.

3.1 heating appliance

item of equipment to provide domestic heating, including open fires

3.2 fireguard

product intended to limit access to domestic heating appliances and open fires

3.3 moveable fireguard

fireguard for use with portable heating appliances

3.4 permanently fixed fireguard

fireguard which is intended to be permanently fixed to a wall, for use with a heating appliance that is situated on the floor, on a hearth, within a recess, against or near a wall of a flue system and/or against or near to a wall at a point of fuel supply

3.5 detachable fireguard

fireguard which is intended to be detachable from a wall, for use with a heating appliance that is situated on the floor, on a hearth, within a recess, against or near a wall of a flue system and/or against a wall at a point of fuel supply
